## Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in Chinese convertible bonds and exchangeable bond. The Fund will invest through the Shanghai and Shenzhen Hong Kong Stock Connect and/or through the Renminbi Qualified Foreign Institutional Investor (RQFII) licence.

The Fund is actively managed.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

 100% in securities issued or guaranteed by the People's Republic of China (PRC) but in this case the Fund must hold securities from at least 6 different issues and a single issue may not exceed 30% of the total amount. The Fund will not invest in Contingent Convertible bonds (CoCos).

The Fund's base currency is CNH.


Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on a weekly basis, each Monday, except if it is a bank holiday in Luxembourg or if the decisive market is closed: Shangai (CN).

The recommended holding period is minimum 5 years.

# Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

**Political and Social risk:** Investments in China will be sensitive to any political, social and diplomatic developments which may take place in or in relation to China. Investors should note that any change in the policies of China may adversely impact on the securities.


