The Fund seeks to grow your capital and generate income by investing primarily in Chinese convertible bonds and exchangeable bond. The Fund will invest through the Shanghai and Shenzhen Hong Kong Stock Connect and/or through the Renminbi Qualified Foreign Institutional Investor (RQFII) licence.

The Fund is actively managed.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

- 100% in securities issued or guaranteed by the People's Republic of China (PRC) but in this case the Fund must hold securities from at least 6 different issues and a single issue may not exceed 30% of the total amount

The Fund will not invest in Contingent Convertible bonds (CoCos).

The Fund's base currency is CNH.

Any income received by the Fund is reinvested (capitalisation share class).

Any income received by the Fund is reinvested (capitalisation share class). Investors in the Fund can subscribe and redeem units on a weekly basis, each Monday, except if it is a bank holiday in Luxembourg or if the decisive market is closed: Shanghai (CN).

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

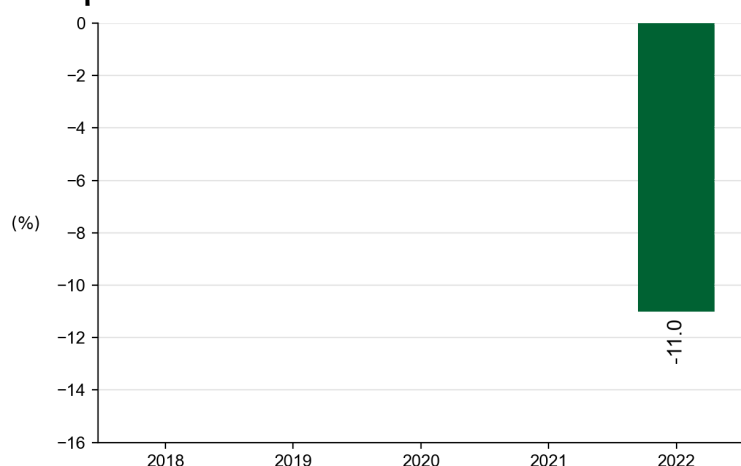
