Objectives and Investment Policy

The objective of the Fund is to generate returns in excess of the MSCI All Country World Index by investing in an unconstrained portfolio consisting of long and short equity opportunities, over market cycles with a strong focus on capital preservation.

The Investment Manager will actively manage the Fund through a bottom-up selection to generate returns on both long and short leg investments. The Investment Manager has full discretion over the composition of the Fund's portfolio and therefore its composition may deviate substantially from the Benchmark so as to take advantage of specific investment opportunities.

The Fund aims to achieve its investment objective by investing in liquid equity and equity-related instruments (including convertible bonds) primarily issued by mid-large capitalization companies globally located.

The core portfolio of the Fund is expected to be constructed of global equity securities, exchange-traded and OTC equity options, exchange-traded equity futures and other financial derivative instruments such as contract for difference (CFD) and funded and/or unfunded total return swap (TRS).

Investments in equity and equity related securities of companies located in Emerging Market countries are allowed up to 20% of the Fund's net

assets. Within these limits, the Fund may gain exposure to Stock Connect Shares through the use of TRS.

The Fund may also take an indirect exposure to the above listed instruments by investing through UCITS, UCIs or ETFs.

The Fund may also hold, up to 40% of its net assets in in liquidities.

The Fund may also invest up to 10% of the Fund's net assets into "Rule 144A" securities, which in accordance with US Law are not registered with the US Securities and Exchange Commission (SEC).

The Fund may use financial instruments and derivatives for hedging purposes, for efficient portfolio management purposes and for investment purposes.

The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

The Share Class makes no dividend payment.

The Benchmark of the Fund is the MSCI All Country World Hedged to USD Net Total Return Index.

Counterparty Risk: The Fund primarily concludes derivatives trades with various contracting parties. There is a risk that counterparties may no longer be able to honour their payment or settlement obligations.

Geopolitical Risk: Risk related to the investments in geographic areas or sectors that may be sensitive to any event of economic, geopolitical or regulatory nature or any other events beyond the control of the Management Company that could expose the Fund to losses.

Operational Risk and Depositary Risk: The Fund may fall victim to fraud or other criminal acts. It may also incur losses due to misunderstandings or errors by employees of the management company, the depositary or external third parties. Finally, its' management or the custody of its' assets can be adversely affected by external events such as fires, natural disasters etc.

Performance fee: Positive or negative Performance Adjustment of the Variable Management Fee up to +/- 2.55% from the VMF Midpoint of 2.94% with a VMF Minimum 0.39% and VMF Maximum of 5.49%. The performance adjustment depends on whether, and to what extent, the Fund's performance exceeds, or is exceeded by, the VMF Midpoint Hurdle (i.e., the Benchmark plus 8.5%) during the Performance Period. The Fund's last financial year Performance Fee was 0.00%.

The entry and exit charges shown are maximum rates. In certain cases, the charges paid may be lower.

Ongoing charges are based on the charges for the previous 12 months, ending on 31 December 2021. This percentage may vary from year to year. 
A conversion commission of up to 5.00% maximum of the net asset value per share class to be converted may be charged.
