Objectives and Investment Policy

The objective of the Fund is to generate superior long-term risk adjusted returns in excess of the MSCI Europe Net Total Return EUR Index by investing in a portfolio exposed essentially to European equities and equity-related instruments.

The Investment Manager will actively manage the Fund through a bottom-up selection to generate returns on both long and short leg investments. The Investment Manager has full discretion over the composition of the Fund's portfolio and therefore its composition may deviate substantially from the Benchmark so as to take advantage of specific investment opportunities.

The Fund will take long exposure in equity and equity-related securities of companies where innovation is driving under-appreciated growth, competitive advantage and re-rating opportunities.

At least 70% of the Fund's portfolio will be invested in equities of companies listed or domiciled in a European country or conducting most of their economic activity in Europe.

Under normal market conditions, the Fund is expected to hold long positions of approximately 90-130% and indirect short positions of approximately 0-30% of the net assets.

The Fund may also invest in UCITS, UCIs or UCITS-ETFs and ETCs.

The Fund may hold up to 40% of its net assets in liquidities such as cash deposits, money market UCIs and Money Market Instruments.

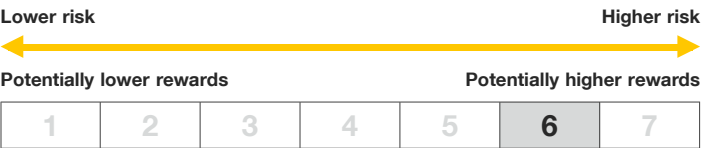
The Fund may use financial instruments and derivatives for hedging purposes, for efficient portfolio management purposes and for investment purposes.

The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

The Share Class makes no dividend payment.

The Benchmark of the Fund is the MSCI Europe Net Total Return EUR Index.

Risk and Reward Profile



This indicator represents the annual historical volatility of the Fund over a 5-year period. Its aim is to help investors understand the uncertainties attached to gains and losses that may have an impact on their investment.

### Charges taken from the Fund under certain specific conditions

**Performance fee:** Positive or negative Performance Adjustment of the Variable Management Fee up to +/- 2.55% from the VMF Midpoint of 2.85% with a VMF Minimum 0.30% and VMF Maximum of 5.40%. The performance adjustment depends on whether, and to what extent, the Fund's performance exceeds, or is exceeded by, the VMF Midpoint Hurdle (i.e., the Benchmark plus 8.5%) during the Performance Period. The Fund's last financial year Performance Fee was 0.00%.

The entry and exit charges shown are maximum rates. In certain cases, the charges paid may be lower.

Ongoing charges are based on the charges for the previous 12 months, ending on 31 December 2021. This percentage may vary from year to year. It excludes performance fees, if applicable, and portfolio trade-related costs, with the exception of costs paid to the custodian and any entry/exit charge paid to an underlying collective investment scheme.

A conversion commission of up to 5.00% maximum of the net asset value per share class to be converted may be charged.

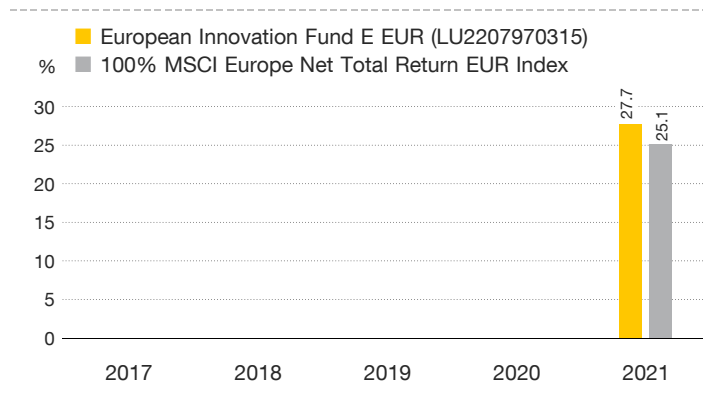
