UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in global credit market with a credit rating of B+ (S&P or FITCH), B1 (Moody's) or above.

The Fund is actively managed.

The Fund is allowed to invest in currencies other than its base currency (USD), but the currency risk is limited to 20% of the net assets.

A minimum of 50% of the bond investments will be in issuers deemed to maintain sustainable characteristics with a minimum ESG rating of BBB for developed market issuers and BB for emerging market issuers or if such rating is not available an equivalent internal rating assigned by the Investment Manager. ESG investment strategy is based on three pillars: (i) Sector exclusion according to the UBP Responsible Investment policy; (ii) ESG integration to select issuers through the analysis of environmental, social and governance factors; (iii) a preference for Green, Social and Sustainability bonds.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to: - 100% in High Yield

- 100% in Investment Grade
- 50% in Emerging Countries (including China through Bond Connect)
 20% in Contingent Convertible Bonds (Cocos)
- 20% in asset backed securities (ABS)
- 10% in equity, including equity derivatives

At any time, this Fund invests a majority of its net assets in bonds and other debt securities, including derivatives such as but not limited to futures, options, swaps and CDS (Credit Default Swaps).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products


The Fund's value is calculated and expressed in US Dollars.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US) and United Kingdom (UK). Details of the closing days are available here

Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honor its contractual obligations. This may result in a financial loss for the Fund.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Emerging country risk: The Fund invests in developing overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.


