Objectives and Investment Policy

Investment objective: The Sub-Fund's investment objective is to outperform its benchmark by investing in a portfolio of international convertible or exchangeable bonds and other similar

Benchmark index: The benchmark index of the Sub-Fund is Refinitiv Global Focus Hedged (USD) Convertible Bond Index, calculated with net coupons reinvested

The benchmark index serves only for comparison purposes. The Sub-Fund is actively managed.

Investment policy: The Investment Manager will systematically include environmental, social and governance (ESG) factors in their financial analysis in order to select the highest-rated companies.

At least 90% of portfolio companies receive ESG rating. The selection process includes a positive screening by selecting through a best in universe approach and a negative screening, whereby the Investment Manager has established a formal exclusion policy that integrates the exclusion of controversial companies related to weapon, coal and tobacco. The Sub-Fund Classifies as Article 8(1) SFDR as it promotes a combination of ESG characteristics, although no reference benchmark has been designated for the purpose of attaining the environmental or social characteristics.

Environmental, social and governance (ESG) criteria are one of the components subject to management and are factored in the final investment decision, although their weighting is not defined beforehand.

In view of its ESG strategy, the Sub-Fund promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation.

At least 60% of the Sub-Fund's net assets is permanently invested in convertible and exchangeable Bonds.

Direct or indirect exposure to emerging markets through these instruments and through derivatives and UCIs may represent up to 40% of the Sub-Fund's net assets.

The Sub-Fund will invest up to 110% of its net assets in "investment grade" as well as in "non-investment grade" issues (i.e. respectively those with a rating higher or equal and lower than BBB- according to Standard & Poor's, or an equivalent rating).

The Sub-Fund may expose up to 50% of its net assets to currency risk, regardless of the currency of the Share to which investors have subscribed.

The Sub-Fund may invest up to 25% of its net assets in non-convertible transferable debt securities.

The Sub-Fund may use financial derivative instruments to achieve its investment objective.

In order to meet its investment objective and gain exposure to international equity or interest rate markets, the Sub-Fund may invest up to 110% of its net assets in transferable securities containing an embedded derivative.


The net exposure of the Sub-Fund to equity markets may vary between 20% and 80%.

The recommended minimum investment period is 3 years.

Frequency of share buying or selling: Every Luxembourg and France bank business day except for Good Friday, 24 December (Christmas Eve) and the days on which the French markets are closed (official calendar of Euronext Paris S.A.) and the US markets are closed (official calendar of NYSE) for orders received by the transfer agent on each NAV calculation day before 12:30 p.m. and processed on the basis of that day's net asset value.

Significant risks not taken into account in this indicator:

Credit risk: When a significant level of investment is made in debt securities.

<u>Liquidity risk</u>: The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Sub-Fund, both in the realisation of the prices quoted and the execution of orders at desired prices.

Impact of techniques such as derivative contracts: The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

<u>Counterparty risk</u>: Where a Fund is backed by collateral or has significant investment exposure through contracts with a third party.

Operational risk: The Sub-Fund may suffer losses due to the failure of operational processes, including those related to the safekeeping of assets.

The occurrence of any of these risks may negatively impact the net asset value.

Performance fee

The performance fee is set at 15% and is calculated by comparing the Sub-fund's share performance with that of an indexed reference asset, over the relevant Calculation Period. This fee is due even in the case of a reduction in the Net Asset Value provided that the decrease in Net Asset Value is less than the decrease in the benchmark index. The calculation method is described in the prospectus (outperformance model 2). Payable annually on July 31.

Charges and fees are paid to cover the operating costs of the Sub-Fund, including the cost of marketing and distributing share classes. These costs reduce the potential growth of your investment

Investors may obtain the actual amount of entry and exit charges from their advisor or distributor. In certain cases you might pay less.

The indicated ongoing charges are an estimate based on the expected total amount of charges.

This figure may vary from year to year. It excludes performance fees and intermediary fees except entry and exit charges paid by the Sub-Fund when buying or selling units and/or shares of another UCI.

The performance fee paid for the preceding exercise closing on July 2021 represents 0.00% of net assets.
