Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in convertible bonds or equivalent with no rating constraints, of which the underlying is a worldwide company specializing in healthcare sector.

The Fund is actively managed.

The currency risk is limited to 10% of the net assets of the Fund.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

- 100% in High yield
- 10% in equity (excluding preferred shares).

The equities held by the Fund will only be the result of bond conversions and will be sold within a period of maximum 6 months.

The Fund will not invest in Contingent Convertible bonds (CoCos).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Fund's base currency is USD.

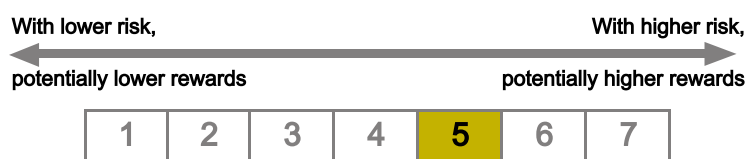
Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US), Luxembourg (LU).

Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.
