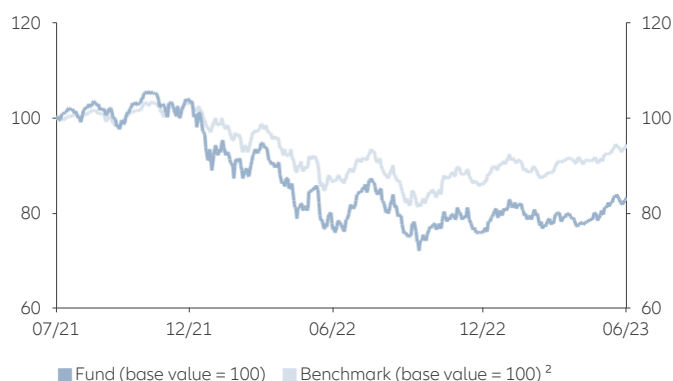

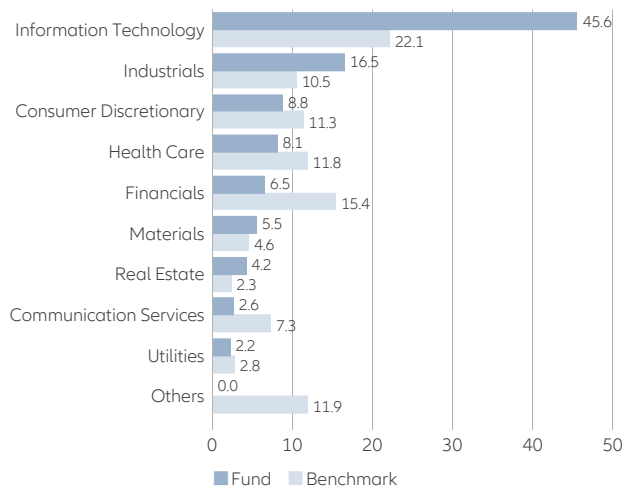

Portfolio Structure ⁶

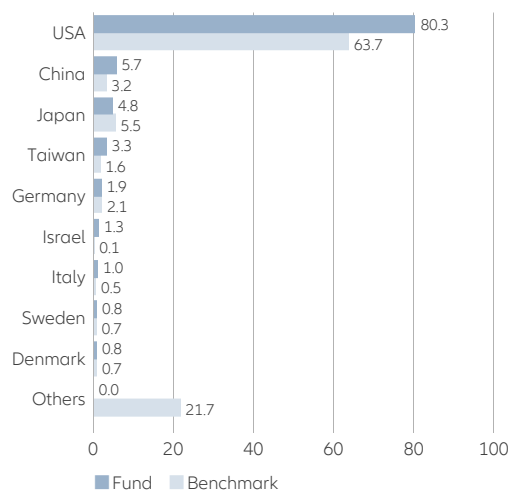
Equity weighting by sector (%)
