

### Fisher Investments Institutional US Equity ESG Fund, USD 1

**Investment Objective:** The investment objective of the Fisher Investments Institutional US Equity ESG Fund (the "Fund") is to outperform the Benchmark. There is no guarantee that the investment objective will be achieved.

**Benchmark:** S&P 500 Index. The Benchmark measures the performance of the large-cap segment of the United States equity universe. The Benchmark includes 500 leading companies and captures approximately 80% coverage of available market capitalisation.

Investment Policy: The Fund invests primarily in equities and equity-related securities of, or linked to, issuers that are in the United States and may invest up to 10% of its total assets in unlisted equities. The Investment Manager considers environmental, social and governance factors throughout the investment and portfolio construction process. The Fund is actively managed by the Investment Manager, meaning that investment decisions are made on a fully discretionary basis. Accordingly, the portfolio holdings may significantly deviate from the Benchmark.
