Objectives and investment policy

The investment objective of the Fund is to provide investors with long-term capital appreciation primarily through investing and trading in equities of Chinese Companies. The Fund may also invest in debt securities, which may be government or corporate.

The Fund's benchmark was the MSCI China A + H Net TR USD (Bloomberg ticker MSCHAHNU) from 3 May 2016 to 31 December 2017. From 1 January 2018 onwards, the Benchmark is the MSCI China A Net Return Index (Bloomberg ticker MBCN1A). The Investment Manager will use its discretion to invest in companies and sectors not included in the benchmark in order to take advantage of investment opportunities and whilst the risk profile of the Fund and the benchmark are similar, the Fund does not seek to track the benchmark.

The Fund invests systematically on the basis of investment ideas and scoring from third-party contributors, selected and refined by Marshall Wace LLP's Trade Optimised Portfolio System ("TOPS") investment process. The Investment Manager can also add its own investment ideas to the Fund's portfolio.

The portfolio construction involves five key elements: investment idea collection to capture and analyse the investment ideas, contributor relationship management to ensure contributors regularly appraise their ideas, optimisation which aims to implement the ideas in a diversified way and in accordance with risk/reward targets, risk management and trade execution as further described in the prospectus.

The Fund may use derivatives, including over-the-counter swap transactions, options, warrants, futures and forward contracts to achieve the investment objective.

The Fund will focus on China but will not focus on any specific sector. Leverage will only be achieved through derivatives.

The Fund is actively managed in reference to a benchmark.

Portfolio transaction costs, which may be material and are not included in the charges disclosed in the "Charges" section, are paid out of the assets of the Fund.

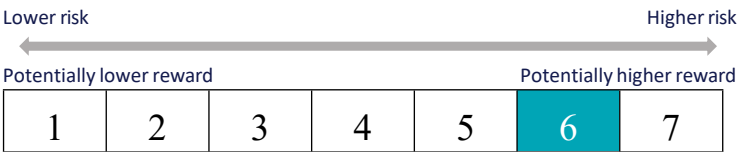
The currency of the Fund is USD and your shares will be denominated in EUR. Your shares will be hedged with the aim of protecting them from exchange rate fluctuations between their denominated currency and the currency of the Fund.

Your shares are non-distributing (i.e. any income arising from your shares will be included in their value).

Investors can redeem and subscribe for shares in the Fund on demand on every Business Day on which banks are open for business in Luxembourg, London, Dublin and Shanghai or the next following Business Day if such day is not a Business Day.

Risk and reward profile

The Fund is rated 6 due to the nature of its investments which include the following risks:

Derivatives risk: The Fund may use derivatives for investment purposes. Derivatives are highly sensitive to changes in the value of the asset on which they are based, which may result in greater fluctuations in the value of the Fund. The impact to the Fund can be greater where derivatives are used in an extensive or complex way.

Equity risk: The risk that the value of equities and equity-related securities within the Fund may be affected by a change in the stock market movements or changes in a company's financial condition.

Emerging market risk: The Fund may invest in less economically or politically developed markets which can involve greater risks than well developed economies. Political/economic instability, lack of liquidity or transparency, or safekeeping issues should be considered.

China risk: The Fund is exposed to political risk linked to investment in companies operating or having exposure to the People's Republic of China ("PRC").

Currency risk: The risk that the investment's value may change due to fluctuations in exchange rates between currencies. Securities denominated in foreign currencies are subject to movements in exchange rates and may result in reduced returns in the Fund.

Stock Connect risk: The Fund is exposed to regulatory and operational risks in some of the markets it may invest including the Shanghai - Hong Kong Stock Connect programme.

The following are additional risks which are not captured in the risk category:

Liquidity risk: The risk that insufficient buyers or sellers to an investment, or an impairment in the market may affect the price or the ability to sell such investment within the Fund.

Counterparty risk: The risk that the other party to a transaction with the Fund may fail to fulfil its contractual obligations and may expose the Fund to financial losses.

Your investment is not guaranteed and its value can go down as well as up.

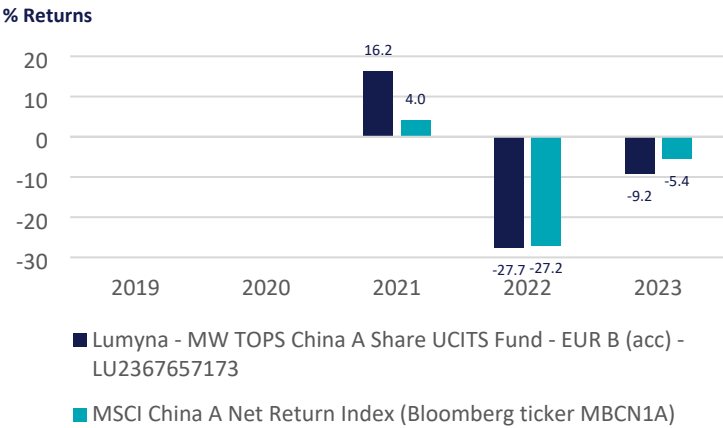

It excludes portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another fund. An Anti-Dilution Levy of up to 1.5% net redemption proceeds may be applied to redemptions.

This includes 1.25% management fees and 0.20% maximum estimated research charge.

Conversion charge: up to 5.00%.
