INTRODUCTION

Valour Solana (SOL) is an exchange-traded product which makes investment in SOL simple, secure and costeffective.

CALCULATING THE PRICE OF **VALOUR SOLANA (SOL)**



We calculate the arithmetic mean price from four major exchanges¹



Using market rates, we convert the dollar value of SOL (SOL/USD) into the product currency (SEK)



We deduct an annual management fee daily on a pro rata basis



We apply the multiplier 0.1 to set the price of one certificate, making it an affordable unit price

1 The reference price is set using the average price of the underlying (SOL/USD) from the four most liquid exchanges. The exchanges used may vary depending on their trading volumes.
