# **Qblue Global Sustainable Leaders Fund - Class C (USD)**

A sub-fund of Heptagon Fund ICAV (the "ICAV"), which is an open-ended umbrella type investment vehicle with segregated liability between sub-funds. Heptagon Capital Limited is the Investment Manager, Qblue Balanced A/S is the Sub-Investment Manager and Carne Global Fund Managers (Ireland) Limited is the Manager.

## **Objectives and Investment Policy**

#### Objective

The investment objective of the Fund is to achieve long-term capital growth, by investing globally in the shares of companies that the Sub-Investment Manager believes contribute positively to social and environmental factors.

### Investment Policy

The Sub-Investment Manager's approach to sustainability is based on a three-step process. (1) Engagement and/or exclusions, seeks to identify the companies in the investment universe to engage with or to exclude; (2) Identify industries or sub-sectors with unwanted inherent sustainability risks where mitigation is deemed insurmountable; (3) Utilisation of a proprietary sustainability model, Sustainability CubeTM, to identify "best-inclass" sustainable companies. The model scores and ranks companies in the investment universe according to their sustainability standards along several dimensions. Dimensions considered include, but are not limited to; climate transition, ESG industry leadership and UN SDG alignment. As sustainability data may be insufficient and incomplete, a broad range of data quality enhancements may be required to ensure robustness. The Fund is actively managed which means the Sub-Investment Manager is

actively making investment decisions for the Fund. The Fund measures its performance for comparative purposes against the MSCI World NR USD Index ("the Benchmark"). However, when selecting investments, the Fund is not required to follow the composition of this index. Additional information is detailed in the Prospectus.

#### Dividend Income

Dividend Income that the Fund receives is automatically reinvested into the Fund and is thus part of the share value.

#### Investment Period

Recommendation: The Fund is suitable for investors who seek capital appreciation over a long-term horizon but who are prepared to accept a medium to high level of volatility from time-to-time. Subscription and redemptions of the shares can be carried out on all Irish and Danish business days by 14:00 hours Ireland time.
