Risk considerations





The result is expressed as a notional percentage (positive or negative) of sales of the relevant underlying companies and other issuers. 

The "Overall Impact" shown is a measure of the fund's estimated impact compared to that of its benchmark, in each case calculated as a relative notional percentage as described above.




Overall Impact On: People



Some performance differences between the fund and the benchmark may arise because the fund performance is calculated at a different valuation point from the benchmark. Impact scores: These are generated using Schroders' proprietary tool SustainEx™.
