
#### Investment overview

#### **OBJECTIVE & PORTFOLIO ASSETS**

To increase the value of your investment, through income and investment growth. A sustainable strategy of low carbon emission exposure in view of achieving the objectives of the Paris Agreement is also applied.

The Compartment mainly invests in government bonds issued by countries that are reducing their greenhouse gas emissions and carbon intensity (net of land and forestry management) or in the opinion of the investment manager are in the process of implementing policies that may lead to a meaningful improvement. The Compartment may invest worldwide, including in emerging markets and Mainland China, and can invest across any currency. These may include Sharia-compliant bonds. Some of these investments may be below investment grade.






#### Maturity profile (% of asset)

#### **Financial Glossary**

#### **Conversion fee**

Fee paid for the transfer of shares of one unit/share class to another unit/share class.

#### Inception date

The inception date is the date taken into account for the start of performance calculation. It corresponds to the launch date.

#### Launch date

The launch date is the date when the sub-fund was activated in its current legal status.

#### NAV

An acronym of net asset value.

#### **Order deadline**

Deadline for remittance of orders to the transfer agent in Luxembourg as set out in the relevant annexes to the prospectus. You may be required to submit your orders to your financial advisor or fund distributor by an earlier cut-off time.

#### Rating

The rating is a score awarded by rating agencies reflecting their opinion on the creditworthiness of an issuer.

#### **Ongoing Costs**

The ongoing charges figure is based on expenses for the last 12 months. This figure may vary from year to year. It includes the management fees and other administrative or operating costs. It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit charge paid by the Compartment when buying or selling units/shares in another collective investment undertaking. # GHG Intensity of investee countries (KtCO2e/GDP USDm)

This indicator measures the amount of carbon produced per unit of Gross Domestic Product (GDP), measured in Kton per USDm of gross domestic product (GDP). GHG emissions include both territorial and traded emissions from energy use, land use, land use changes and forestry.

#### Labelled bonds (%-weight)

Labelled bonds include green, social and sustainability bonds. Classification

of labelled bonds is provided by the bond issuer and may not reflect our internal view.

#### SFDR Classification
