## KEY INVESTOR INFORMATION

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

### UBAM - Absolute Return Fixed Income, a sub-fund of UBAM

**Class: AC EUR (Capitalisation) LU1315123684**

UBAM is managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in worldwide bonds, money market instruments, fixed income and currency derivatives such as but not limited to Credit Defaults Swaps (CDS), futures, swaps and options.

The Fund is actively managed with an absolute return approach and seeks a positive performance above the prevailing cash rate in the reference currency of any given share class.

The Fund is allowed to invest without limits in currencies other than its base currency (EUR) but the currency risk is limited to 30% of its net assets.

A minimum of 50% of the bond investments will be in issuers deemed to maintain sustainable characteristics with a minimum Environmental, Social and Governance (ESG) rating of BBB for developed market issuers and BB for emerging market issuers as measured by MSCI ESG research or if such rating is not available an equivalent internal rating assigned by the Investment Manager. ESG investment strategy is based on three pillars: (i) Sector exclusion according to the UBP Responsible Investment policy; (ii) ESG integration to select issuers through the analysis of ESG and financial factors; (iii) a preference for Green, Social and Sustainability bonds.

A performance fee -defined in the "Costs" section- is applied to some share classes (the "Benchmark"). The Benchmark is not representative of the risk profile of the Fund and the performance of the Fund is likely to be significantly different from that of the Benchmark because the Investment Manager has significant discretion to deviate from its securities and weightings.

The Fund may invest its net assets up to:

- 80% in High yield
- 60% in Emerging countries (including China through Bond Connect)
- 20% in Asset Backed Securities (ABS)
- 20% in equity including equity derivatives
- 20% in Contingent Convertible bonds (CoCos).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Fund's base currency is EUR.

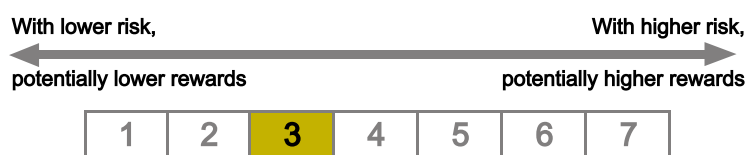
Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US), United Kingdom (UK), Eurex.

The recommended holding period is minimum 3 years.

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 3-year period.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Bond Connect risk:** Investment through Bond Connect is subject to additional risks mainly regulatory and tax.

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this

happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging countries risk:** The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**ESG and Sustainability risk:** It may result in a material negative impact on the value of an investment and performance of the Fund. Assessment of sustainability risks is complex and requires subjective judgments, which may be based on data which is difficult to obtain and/or incomplete, estimated, out of date or otherwise materially inaccurate. All or part of said data may come/originate from third parties.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

**Political and Social risk:** Investments in China will be sensitive to any political, social and diplomatic developments which may take place in or in relation to China. Investors should note that any change in the policies of China may adversely impact on the securities.

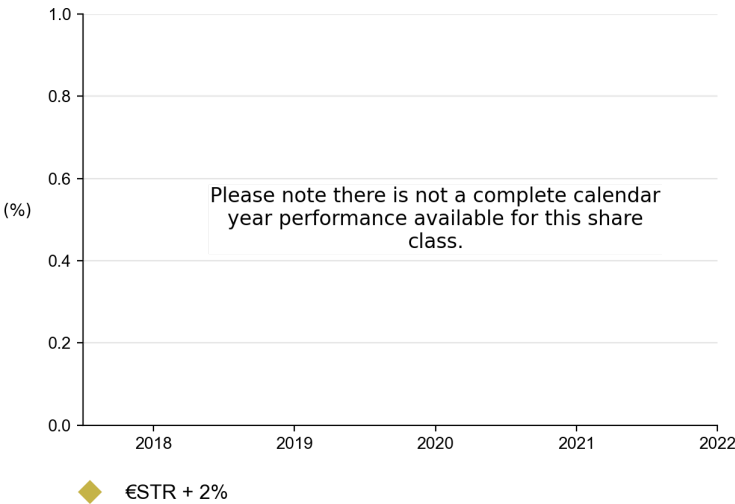
