#### **INTRODUCTION**

Valour Ethereum Zero is a synthetic exchange traded product (ETP) designed to precisely track the price of ETH without charging management fees, making investment in the world's second largest digital asset easier, more secure and more cost-effective than all other options. This ETP is structured as a tracker certificate under Swedish law and trades on various exchanges.

### **CALCULATING THE PRICE OF ETHEREUM ZERO**



We calculate the arithmetic mean price from four major exchanges<sup>1</sup>.



Using market rates, we convert the dollar value of ETH (ETH/USD) into the product currency (EUR).



We apply the multiplier 0.01 to set the price of one certificate, making it an affordable unit price


