INVESTMENT OBJECTIVE

To maximise the value of its shares through both growth in the value of, and income from, its investments.

INVESTMENT PROCESS

The fund is actively managed and invests mainly in a portfolio of bonds of all types from emerging markets issuers. Although the fund does not have sustainable investment as an objective, the promotion of environmental and/or social characteristics is achieved through the fund's commitment to maintain at least 50% of the value of its portfolio invested in issuers and/or securities that are rated as 'Green' by the T. Rowe Price proprietary Responsible Investor Indicator Model (RIIM). In addition to the E/S characteristics promoted, the fund also applies the investment manager's proprietary responsible screen (the T. Rowe Price Responsible Exclusion List). The fund may use derivatives for hedging, efficient portfolio management and investment purposes. The fund may also use derivatives to create synthetic short positions in currencies, debt securities, credit indices and equities. Effective 1 November 2021, the fund changed its comparator benchmarks from the 3-month USD and EUR LIBOR to the ICE BofA US 3-Month Treasury Bill Index and EURO Interbank Offered Rate 3 Months respectively, in anticipation of the transition away from use of LIBOR settings. Historical benchmark representations have not been restated.

KEY FUND RISKS
