

BlueBay Emerging Market Bond Fund

Investment objective

The fund is actively managed and targets better returns than its benchmark, the JP Morgan Emerging Market Bond Index Global Diversified, while taking into account Environmental, Social and Governance (“ESG”) considerations.

Investment strategy

- There are no restrictions on the extent to which the fund's portfolio and performance may deviate from the ones of the benchmark.
- At least two-thirds of the fund's investments will be in fixed income bonds of any rating issued by governments, banks and corporates of emerging market countries denominated in any currency.
- The Fund meets the conditions set out in Article 8 of the Sustainable Finance Disclosure Regulation as it promotes environmental/social characteristics through binding requirements as a key feature. 

Outlook

- April saw markets repricing core rates higher with the US 10-year ending the month at 4.68%.
- As the US economy continues to exhibit strength and inflation remains stickier than expected, the narrative has shifted from how many rates cuts this year to whether there will be any rate cuts at all, or even possibly a rate hike.
- Elsewhere, with Iran's unprecedented attack on Israel from its territory and Israel's retaliation, we have entered a new paradigm – one not seen for the last 50 years.
- On a medium- to longer-term view, despite the ongoing volatility, the case for investing in EMs remains strong.
- The latest PMIs show an increasing trend in upside surprises for many EMs, while inflation in the EM world remains contained and the carry of the asset class remains close to decade highs.
- Short-term performance, however, is likely to remain a little choppy as markets grapple with the uncertainty around the US rates path.





Asset type breakdown (% NAV)




Credit quality breakdown (% NAV)




Important risk considerations

- At times, the market for emerging market bonds may dry up, which could make it difficult to sell these bonds, or the fund may only be able to sell them at a discount.
