INVESTMENT OBJECTIVE

The investment objective of the Sub-Fund is to invest in a diversified portfolio of securities issued by US and Canadian companies in order to outperform the S&P 500® Index (the "Benchmark") on a net of fees basis over a three to five year period.

MONTHLY STRATEGY

The portfolio outperformed the benchmark this month due to favorable stock selection which more than offset the overall adverse impact of sector allocations. Stock selection in Information Technology, Industrials, and Consumer Discretionary contributed most to relative results.

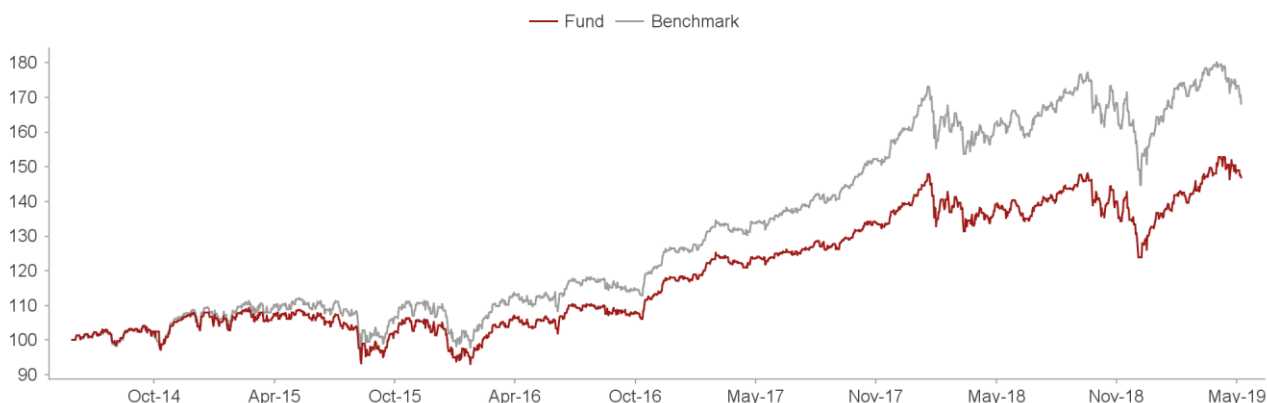
