iShares Dow Jones Global Titans 50 UCITS ETF (DE) is an exchange traded fund (ETF) that aims to track the performance of the Dow Jones Global Titans 50 Index as closely as possible. The ETF invests in physical index securities. The index measures the performance of 50 leading multinational companies from the Dow Jones Global IndexSM, a broad market benchmark covering 51 countries. Components and weightings are selected based on screening criteria such as free float market capitalisation, sales/revenue and net income. iShares ETFs are funds managed by BlackRock. They are transparent, cost-efficient, liquid vehicles that trade on stock exchanges like normal securities. iShares ETFs offer flexible and easy access to a wide range of markets and asset classes. 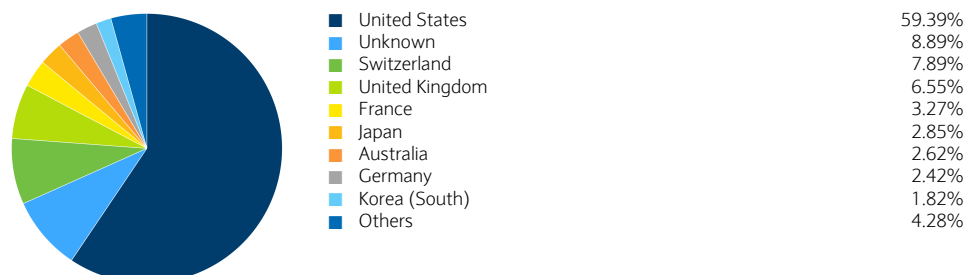
Sector allocation (3 April 2014)

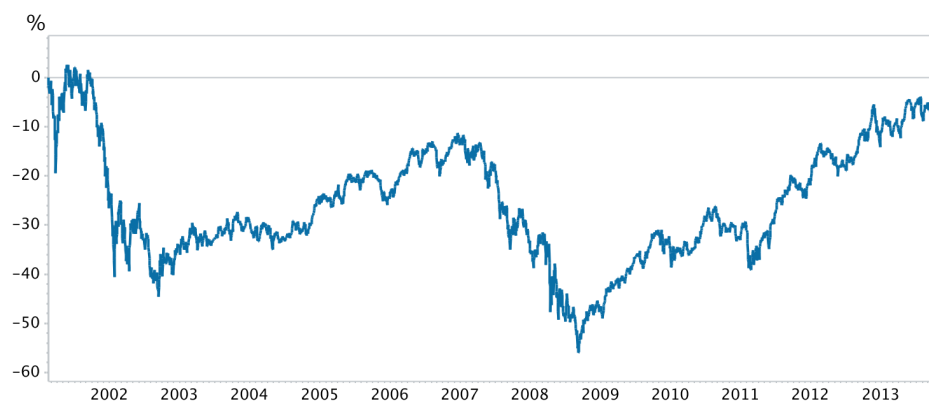
