Objectives and investment policy

The fund invests mainly in securities listed in euro-zone exchanges. Stock picking is carried out according to fundamental analysis and focuses on companies that appear undervalued when comparing market value to intrinsic value. The portfolio is managed proactively, therefore portfolio turnover is high.

The sub-fund is denominated in EUR.

You have the right to redeem your shares. Redemption of operations takes place every Tuesday in Luxembourg (Valuation Day). Redemption requests must be received by European Fund Administration no later than

14.00 am (Luxembourg time) on the business day in Luxembourg before the Valuation Day. The attention of investors is drawn to the fact that, in exceptional circumstances, the possibility for investors to seek reimbursement may be limited or suspended.

In principle, income from shares in this sub-fund is re-invested (capitalised).

Recommendation

This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

What does this synthetic indicator mean?

- The sub-fund SABADELL FUNDS SICAV - NOVEUROPE is classified in category 6 because the value of the share may be subject to significant variations and consequently the risk of loss and the potential gain may be high.

Which risks are not included in this synthetic indicator?

- **Market risk:** general risk associated to the volatility and to the fluctuations in the price of any type of asset. The price of securities specifically depends on the performance of financial markets, as well as on the economic evolution of the issuers, who, in turn, are affected by the global economy and by specific political and economic

circumstances of its territory. In particular, investments are subject to the following risks: **market risk for investment in equity, interest rate risk and currency risk.**

- **Liquidity risk:** Investing in securities with small capitalization and / or in markets of reduced size and a low contracting volume lowers the liquidity of such investment, which can negatively affect the conditions under which the fund can buy, sell or modify its positions.
- **Counterparty risk:** risk that the counterparty of a trade fails to comply with his obligations.
- **Operational risk:** risk of incorrect functioning of the organization in which the fund operates.
- **Risk linked to the use of derivatives:** additional risks with respect to the spot market, as a result of leverage, which can multiply the effects of losses of value of the portfolios, and for those derivatives that are not negotiated in regulated markets, risks like the one consisting in a counterparty failing to comply, for not existing a centralized exchange that assures the correct functioning of the operations.

There is no charge for the exchange of some or all of your shares for shares in a share class of another sub-fund.

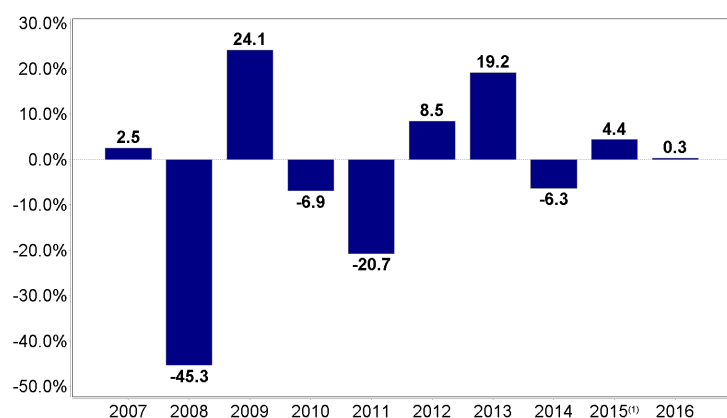
The ongoing charges relate to the annual charges; they were calculated on 31.12.2016. The ongoing charges may vary from year to year.
