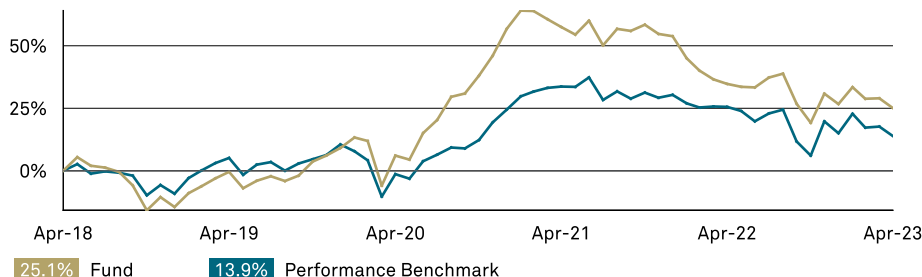
## INVESTMENT OBJECTIVE

Effective 07th November 2022, the Fund name changed from BNY Mellon Asian Equity Fund to BNY Mellon Asian Opportunities Fund.

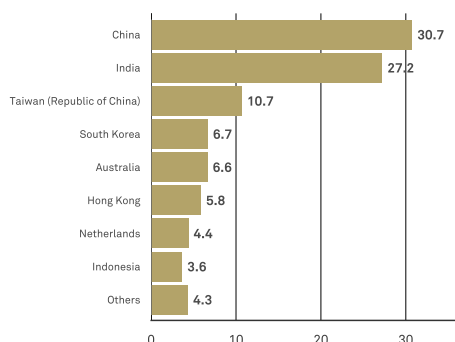

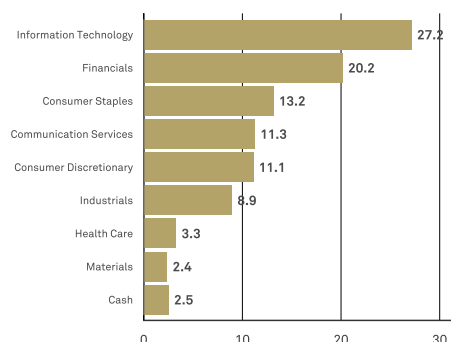

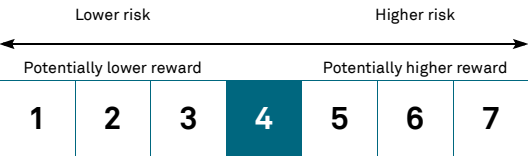
