## Objectives and investment policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares of Eurozone mid-sized companies.

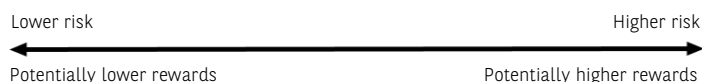
It is actively managed and as such may invest in securities that are not included in the index MSCI EMU Mid Cap.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

- Why is the Fund in this specific category?  
The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.

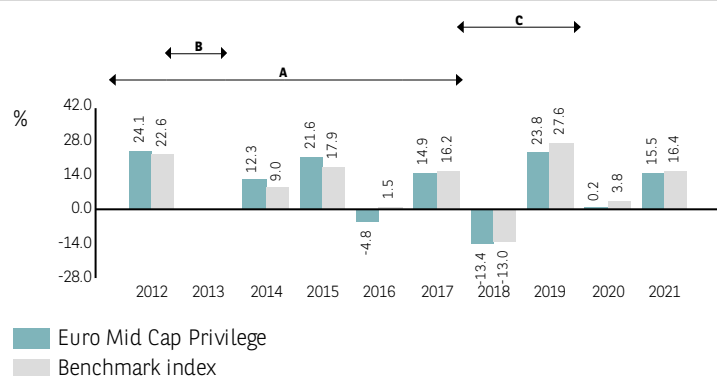
(\*) The **ongoing charges** figure is based on past expenses determined as of 31 October 2021.
