

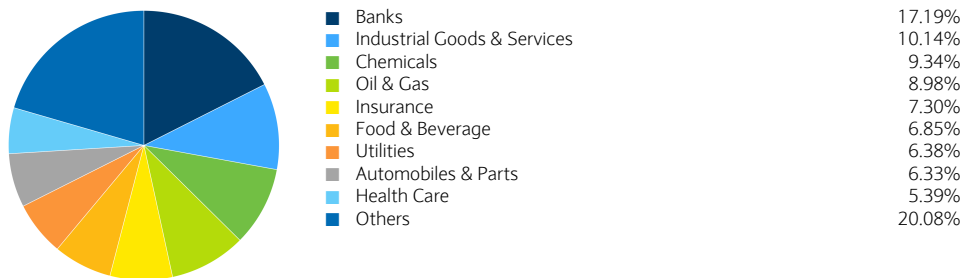

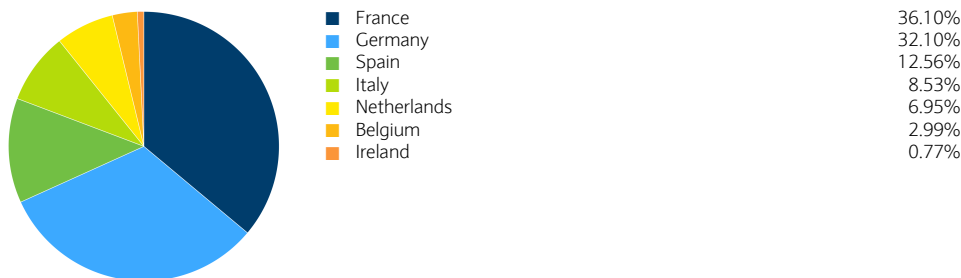
Sector allocation (3 April 2014)

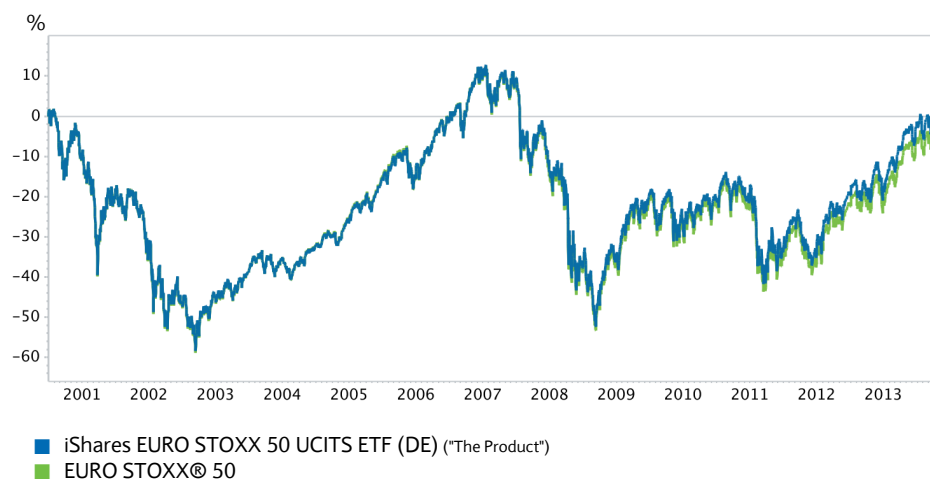
