INVESTMENT UNIVERSE

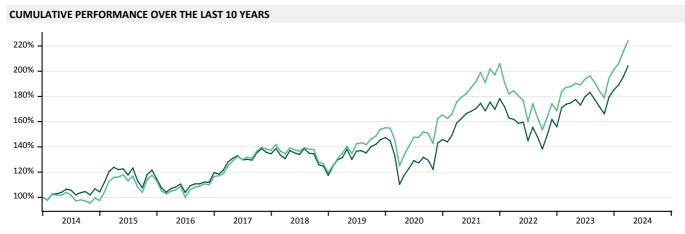
