Investment / Performance Objectives & policy

The fund mainly invests in US government bonds denominated in US dollar. The fund generally favours direct investment but may at times invest through derivatives.

Specifically, the fund normally invests at least 80% of total net assets in debt and debt-related instruments, including money market instruments, issued by the US government and denominated in USD. The credit rating and duration of securities are usually consistent with those of the benchmark.

The fund may invest in the following asset classes up to the percentages of total net assets indicated: - corporate and non-US government debt instruments: 20%

The fund does not invest in asset-backed securities or contingent convertible bonds (coco bonds), but may be indirectly exposed to them (maximum 10% of total net assets).

Non-USD investments are hedged to USD.

The fund may use derivatives for reducing risks (hedging) and costs, and to gain additional investment exposure.





Contribution to Duration by Maturity



Investment Manager Commentary

Performance and Investment Choices

In March, the performance of the US bond market was +0.66%, in USD terms.

During the month the Federal Reserve kept the target range for the Federal Funds rate unchanged for the fifth consecutive meeting at a level of 5.25% – 5.50%, as widely expected by market participants. Chairman Powell reiterated the need to see some more good inflation readings before starting to cut interest rate this year. The so-called "dots plot" projected the Fed funds rate to fall 75bps in 2024, 75bps in 2025 as well as in 2026 for a total 225bps of easing by the end of 2026. Projection for 2024 US GDP growth was increased to 2.1% from a previous figure of 1.4%.

On the macroeconomic side the CPI headline YoY printed at +3.2%, higher than the market consensus of +3.1%. The CPI core YoY data surprised to the upside as well, coming out at +3.8% vs an estimate of +3.7%. Labour market data were mixed: on the one hand, payrolls data came stronger than expected, while prior data was revised downward. Unemployment rate ticked to 3.9%, higher than analysts' forecast of 3.7%. Durable goods orders and retail sales figures came lower than expectations, as well as the ISM Manufacturing reading which was 47.8 vs an estimate of 49.5.

Over the month the US government yield curve bull flattened, with rates down by 5bps from the belly of the curve onwards. Short-end rates remained unchanged. The 2yrs benchmark bond closed the month at a level of 4.61%, some 39bps higher than the yield offered by the 10yrs benchmark bond. As far as the EUR/USD exchange rate is concerned, USD appreciated by +0.19% relative to the EUR.

Fund performance was in line with the one posted by its benchmark. Over the month the fund further increased the long duration positioning, relative to the benchmark, on the short-end of the yield curve. The steepening position was augmented by buying futures on the 5yrs maturity sector while selling futures on the 30yrs maturity sector.
