Fund objectives and investment policy

The fund aims to provide capital growth in excess of the Russell Nomura Small Cap (TR) Index after fees have been deducted over a three to five year period, by investing in equities of small-sized Japanese companies. The fund is actively managed and invests at least two-thirds of its assets in equities of small-sized Japanese companies. These are companies which, at the time of purchase, are considered to be in the bottom 30% by market capitalisation of the Japanese equities market. The fund may also invest directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash. The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.




