Objectives and investment policy

Increase the value of its assets by appreciating the performance on 2 axes (income and/or dividend coming from by investments and capital appreciation coming from market price changes) over the medium term by investing primarily in euro denominated bonds while maintaining the duration at a low level by investing in government and/or corporate bonds and other debt instruments denominated in EUR.

The sub-fund will run an average maturity that does not exceed 3 years.

Investment grade structured debts may represent up to 20% of the assets


It is actively managed and as such may invest in securities that are not included in the index which is Bloomberg Barclays Euro Aggregate 1-3 Years (RI).

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus

Risk and reward profile

- <u>Credit Risk</u>: This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
