Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income on your investment over time.

Investment Policy:

The Fund will invest primarily in equity securities (i.e. shares) or similar securities of companies of Türkiye. This means companies based in Türkiye or companies from any country, but which carry out most of their business in Türkiye.

The Fund invests in companies of any size.


The Fund may invest up to 10% of its assets in other funds, including HSBC funds and may invest in bank deposits, money market instruments for treasury purposes.

The Fund may use derivatives for hedging and cash flow management. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund

 The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.

- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is BIST 100.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark
- The reference benchmark has a high level of concentration. This
 means that a small number of securities make up a significant
 proportion of the benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Material risks not fully captured by the Risk and Reward Indicator:

 Concentration Risk The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 08 February 2024.
