Objectives and Investment Policy

Investment Objective: The Sub-Fund seeks to achieve a return in USD in line with prevailing money market rates whilst aiming to preserve capital consistent with such rates and to maintain a high degree of liquidity.

Investment Policy: The Sub-Fund will invest 100% of its assets (excluding cash and cash equivalents) in short term US Treasury debt securities (including Treasury notes and Treasury bills) and, for efficient management purposes, Reverse Repurchase Transactions with highly rated counterparties. Such Reverse Repurchase Transactions will be fully collateralised by US Treasury debt securities with no maturity constraints.

The Sub-Fund may have exposure to investments with zero or negative yields in adverse market conditions.

The weighted average maturity of the Sub-Fund's investments will not exceed 60 days and the initial or remaining maturity of each debt security will not exceed 397 days at the time of purchase.


