## **Objectives and Investment Policy**

#### **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a portfolio of bonds (denominated in Euros), while promoting environmental, social and governance (ESG) characteristics. The Fund's aims to have a higher ESG rating, calculated as a weighted average of the ESG ratings given to the issuers of the Fund's investments, than the weighted average of the constituents of its reference benchmark. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. #### **Investment Policy:**

The Fund will invest normally at least 90% in high quality bonds or similar securities which are denominated in Euros.

The Fund will normally invest in bonds or similar securities issued by governments, government related agencies or companies and also may invest in securities from any country including developed markets and emerging markets.

The Fund includes the identification and analysis of an issuer's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in bonds issued by companies with involvement in specific excluded activities, such as, companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund conducts enhanced due diligence on bond issuers that are considered to be non-compliant with the UN Global Compact Principles.

ESG Credentials, Excluded Activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & expertise from well-established financial data providers. Please refer to the prospectus for more details on ESG Credentials and Excluded Activities. The Fund may invest up to 10% of its assets in bonds issued by issuers based in emerging markets, up to 10% of its assets in asset-backed securities (ABS) and mortgage-backed securities (MBS) and up to 10% in other funds.


The Fund may invest up to 10% of its assets in contingent convertible securities. However, this is not expected to exceed 5%.

The Fund will not invest in bonds issued by issuers with a credit rating below investment grade at the time of purchase and may also invest in bank deposits, money market instruments for treasury purposes.

The Fund may also invest in derivatives and use them for efficient portfolio management purposes, hedging and investment purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets.
   However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, Bloomberg Euro Aggregate.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 3 years.

# Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

#### Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
  impact the performance of callable debt securities (securities whose issuers have the
  right to pay off the security's principal before the maturity date).



#### Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 08 February 2024.
