### Objectives and Investment Policy

The aim is to increase the value of your investment over the long-term by investing primarily in European companies (excluding UK companies).

While the Fund primarily invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies based in and traded on stock exchanges in Europe, it may also invest in companies based in the UK and/or traded on UK stock exchange.

The Fund is actively managed which means the investment manager has discretion to select the companies it chooses to invest in. However, the investment manager does take into consideration the universe of companies represented by the MSCI Europe ex UK Index (Net Return) (the "Index") when selecting investments.

While the Index may inform the selection of potential investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.

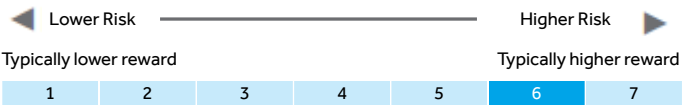
The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.

The Fund relies upon the performance of one or more investment managers. If the investment managers perform poorly, the value of your investment is likely to be adversely affected.

The Fund may use derivatives in an attempt to reduce risk (hedging) or for investment purposes. It may be that the use of derivatives causes share prices to fluctuate which may in turn result in loss to the Fund.

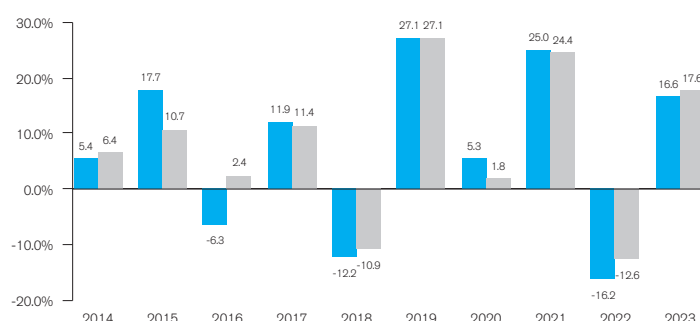
