

Allianz FinanzPlan 2025 - A - EUR

Flexibly structured fund with capital build-up aligned to the target date



Investment Objective

The fund aims to achieve capital growth by 31.12.2025. To this end, fund assets will initially be invested primarily in volatile instruments (in investment products relating to stock-market, commodity-futures, precious-metals, natural-resource, hedge-fund and private-equity indices as well as in emerging market securities). As the target date draws closer, the proportion of assets held in investments that tend not to fluctuate sharply in price (investment products relating to bond, money and real estate markets) will be increased. From the target date on, assets will be held mainly in relatively stable investments generating comparatively steady returns.

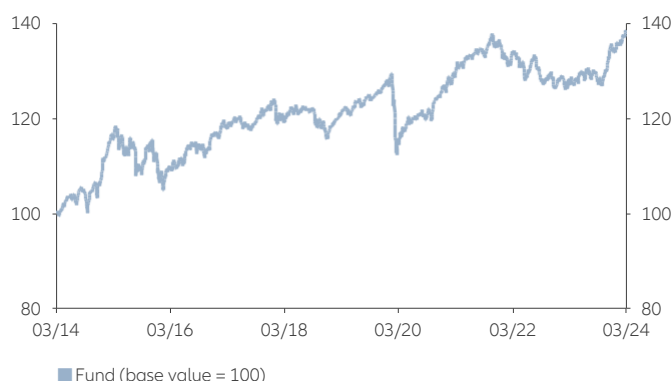

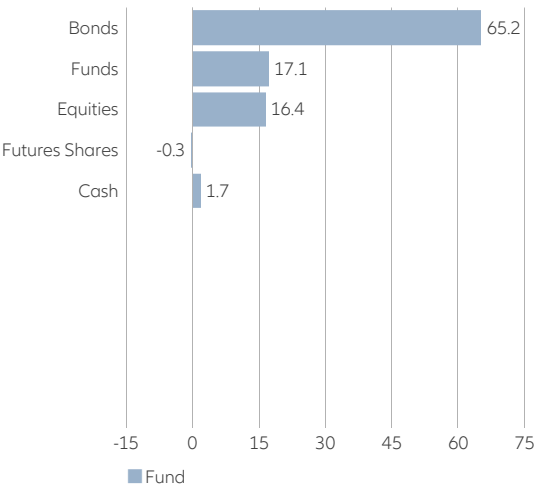
