UBAM is managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income by investing primarily in Emerging countries bonds.

The Fund is actively managed and invests mainly in securities denominated in USD.

The Fund will invest a minimum of 2/3 of its net assets in products/issuers with a minimum rating of B- (S&P or Fitch), B3 (Moody's) or an equivalent rating by another rating agency and up to 1/3 of its net assets in products/issuers with a lower rating.

The Fund may invest up to 15% of its net assets in non-rated

products/issuers.

To achieve its aims the Fund invests in bonds issued by Emerging countries governments and companies. Some of the issuers may be considered highquality, with a low risk of defaulting on their interest payments, while other issuers are companies or governements that may be considered at higher risk. The Fund can also use complex derivatives, primarily to hedge risks.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

- 100% in High yield. This exposure can be increased up to 120% through derivatives
- 100% in Emerging countries (including China through Bond Connect up to 20%) this exposure can be increased up to 120% through derivatives
- 20% in Contingent Convertible bonds (CoCos).

On an ancillary basis, the Fund may invest in securities from issuers not linked to Emerging countries or in securities denominated in Emerging countries currencies.

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Fund's base currency is USD.


Any income received by the Fund is reinvested (capitalisation share class).

Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Bond Connect risk: Investment through Bond Connect is subject to additional risks mainly regulatory and tax.

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Emerging countries risk: The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

Political and Social risk: Investments in China will be sensitive to any political, social and diplomatic developments which may take place in or in relation to China. Investors should note that any change in the policies of China may adversely impact on the securities


