






#### **Investment Policy**

The fund is managed with an indexed method and is distinguished by broad diversification, low tracking errors, and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The Bloomberg Barclays World Government Inflation-Linked Bond Index measures the performance of investment grade, government inflation linked debt from 12 different developed market countries.

#### Exclusion of controversial weapons\*

Credit Suisse Index Funds and Exchange Traded Funds will no longer invest in companies which are involved in the development or production of nuclear, biological, and chemical warfare agents, anti-personnel mines and cluster bombs. Hence we position ourselves in line with the exclusion list from the Swiss Association for Responsible Investments (SWK - ASIR). The tracking quality of our index funds remains broadly unchanged by these exclusions.
